## 1. Executive Summary

### A. Liquidity Measurement

The current ratio is measuring the short-term solvency of the municipality. It measures the extent to which the municipality's current assets covers its current liabilities. The ratio format divides the total current assets by the total current liabilities as the time or reporting and the norm is that the municipality's current assets will cover its current liabilities by the norm range between 1.5 to 2:1 as per MFMA Circular no.71.

The ratio computation was as follows:

$$\text{Current Assets}/\text{Current Liabilities} (1\ 006\ 803\ 209/589\ 637\ 695) = 1.7$$

The municipality's current ratio was within the norm range of between 1.5 to 2 :1 as at the end of December 2025, the cash and short-term investments balances contributed quite significantly to the unfavourable current ratio for this period with a combined closing balance of R 791 930 342.

### Acid-Test Ratio

The acid-test ratio compares the municipality's "quick assets" (cash and accounts receivable) to its current liabilities. It is used to determine short-term liquidity of the municipality. The ratio format considers the total current assets less inventory items which will normally be difficult to liquidate though the municipality is not trading entity and divide by the total current assets as at the reporting date with a good ratio considered to be 1:1 as a norm.

### **B. Cash Flow and Investment Management**

The municipality's primary bank account closed with a positive balance of about R 24 832 407.77 and short-term investments closed at R767 097 934.90. The combined interest earned on short investment amounts to R 4 238 711.90 as at end of Mid-Term.

Net cash flows from operating activities amounts to a positive R 417 102 001 as at end of Mid-Term, net cash flows from investing activities amounts to R 344 481 697.00 and net increase in cash held amounts to R 72 620 303.00 as at 31<sup>st</sup> December 2024.

### **C. Expenditure management**

The total invoices received from suppliers were 264 during the 2nd Quarter, 202 invoices at a total rand value of R 106 136 091.73 were processed and paid, 62 invoices were in progress as at 31<sup>st</sup> December 2024.

R 101 705 014.69 in purchase orders, R 880 787.93 in sundry purchases, R42 398 175.25 in capital projects and R6 355 675.75 in 3<sup>rd</sup> party payments were processed as at end of Mid-Term, totalling R151 339 653.62.

The municipality incurred an expenditure to an amount of R215 508 739 on employee related costs as at end of Mid-Term. Expenditure on council remuneration was R 8 550 782 for the same period.

Depreciation on non-current assets was R 48 097 192.00.

R 165 347 849 was the expenditure on contracted services. Contracted services include amongst others the security services operational fleet expenses, photocopying machines and vehicle tracking services.

Expenditure on transfers and subsidies was R 4 394 622.00 as at end of Mid-Term.

R 114 926 233 was the expenditure on other operations expenditure programmes.

**Financial ratios on operational expenditure:**

**(i) Employee related cost as % of total operational expenditure:**

Norm is between 25% – 40%

(Employee related cost/Total operational Expenditure) x 100

(R 110 248 900 /R 405 513 055) x 100 = 27% (31.4% in the 1<sup>st</sup> quarter of the 2024/25 financial year)

The municipality has incurred in total R 110 248 900 in employee related costs as at end of the quarter. The expenditure incurred amounts to 27% of the total operational expenditure as at end of the quarter.

**(ii) Contracted services as a % of total operational expenditure:**

Norm is between 2% - 5%

(Contracted services/Total operational expenditure) x 100

(R 83 161 733/ R 405 513 055) x 100 = 21% (24% in the 1<sup>st</sup> quarter of the 2024/25 financial year)

The expenditure on contracted services is currently above the 5% required norm on contracted services currently include amongst others the security services operating leases on office buildings and photocopying machinery and municipal fleet.

(iii) **Capital expenditure budget implementation indicator:**

Norm is between 95% - 100%

(Actual capital expenditure/Budgeted capital expenditure) x 100

(R 132 289 963/R 172 240 890) x 100 = 77% (52% in the 1<sup>st</sup> quarter of the 2024/25 financial year)

(iv) **Operating expenditure budget implementation indicator:**

Norm is between 95% - 100%

(R 405 513 055/ R 312 327 801) x 100 = 130% (114% in the 1<sup>st</sup> quarter of the 2024/25 financial year)

Implementation on the operational expenditure budget was at 130% as at end of first quarter.

**D. Revenue management**

A total of 20 407 water meter readings were captured during the Mid-Term. 18 879 readings were captured in the last quarter of the current financial year.

Total revenue billing on water and sanitation services was reported at R 41 952 622.58 for the 2<sup>nd</sup> quarter (R 39 149 222.67 in the previous quarter). R 19 717 732.60 was the total collection on own revenue for the 2<sup>nd</sup> quarter (47% collection rate), a decline from the 107% collection rate reported in the 1<sup>st</sup> quarter of the financial year.

The appointment of the smart pre-paid water metering was appointed in December 2024. The introductory meeting held virtually in December 2024. The service provider is expected to join the municipality in the 3<sup>rd</sup> week of the January 2025.

The plan to implement the installation and maintenance of the smart water meters is outlined as follows in a process flow:

- The business community has been identified as the targeted customer group for piloting purposes.
- Greater Fetakgomotubatse will be our first area for installations given the larger business community in the area.
- Elias Motsoaledi will be second, followed by Ephraim Mogale and lastly Makhuduthamaga.
- Government departments will be second in terms of the targeted customer group for installations.

- Engagements already initiated with the departments as awareness on the smart pre-paid water meters.
- Households will be the third and last targeted customer group for installations with about 14 areas already identified for potential revenue growth.
- Installation of the bulk smart water meters at all off take points operated by the Lepelle Northern Water and some of the residential estates already identified.

The following processes will unfold during the implementation of the smart water metering:

- Establishment of satellite offices in each sub region as our technical support centre.
- Local municipal offices are to be used as satellite offices, Tubatse & Ephraim Mogale office spaces already secured.
- Training of staff and awareness campaigns to customers on how to utilise the new smart water meter system and request support.
- Establishment of a call centre facility for technical support.
- Installation of the vending points in various convenient stores.
- A one-month trial period is to be implemented in Fetakgomotubatse to test the efficiency of the system.

Notices of disconnection were also served to the government departments, and payments for services have since improved except for two departments (Provincial Public Works & Education), the provincial department of Coghsa is currently discussions between the municipality and the two departments with reconciliations of the outstanding amounts at an advanced stage. The two departments visited the municipal offices for reconciliation of the amounts.

The revenue unit will embark on four revenue enhancement and collection campaigns within the district starting from 1<sup>st</sup> of December 2024, procurement of the promotional material already has started. The campaign will promote payment of basic services, discourage illegal water connections, invitation of the applications as indigents and collection of data for purposes of automation of the billing data.

## **E. Supply Chain management**

The following processes of procurement were implemented as at end of Mid-Term:

- (i) Purchase orders equal or less than R 30 000 VAT Inclusive:

389 Quotations to a total rand value of R5 559 369,94 were processed for the procurement of goods and services.

- (ii) Purchase orders more than R 30 000 but less than R 200 000 VAT Inclusive:

221 Quotations to a total rand value of R 19 711 614,37 were processed for the procurement of goods and services.

- (iii) Purchase orders more than R 200 000 VAT Inclusive:

186 orders with a total rand value of R275 468 596,82 were processed.

The following 29 competitive bidding processes were also implemented as at end of Mid-Term:

- (i) 29 requisitions of goods and services through the competitive bidding processes. 17 were adjudicated and awarded. 3 re-advertised, 8 in progress and 1 withdrawn

The unauthorized irregular, fruitless and wasteful expenditure was within the norm in terms of percentage thought an amount of R 165 181.12 was incurred as fruitless and wasteful expenditure during the quarter, the user department is currently investigating this expenditure. The increased

UIFW from the amounts reported in the previous quarter is noted that no amount is to be incurred as fruitless and wasteful hence corrective measures were implemented to remedy the root causes of the expenditure incurred during the fourth quarter.

The unauthorized, irregular, fruitless and wasteful expenditure was more than the norm of 0% in terms of percentage with an amount of R 165 181.12 incurred as fruitless and wasteful expenditure as at end of Mid-Term. The increased UIFW from the amounts reported in the previous month is noted that no amount is to be incurred as irregular hence corrective measures were implemented to remedy the root causes of the expenditure incurred.

R 2 387 283.64 was the total rand value for all deviations from July 2024 to December 2024, R950 863.55 of this amount was recorded during the month of December 2024. Deviations were for services procured through processes where it was very impractical for the institution to follow the normal procurement processes.

#### **G. Grants performance**

The overall spending on conditional grants was 61% as at end of Mid-Term. The FMG spending at 59% and EPWP spending at 59% while MIG and RRAMs were reported at 34% and 42% respectively.

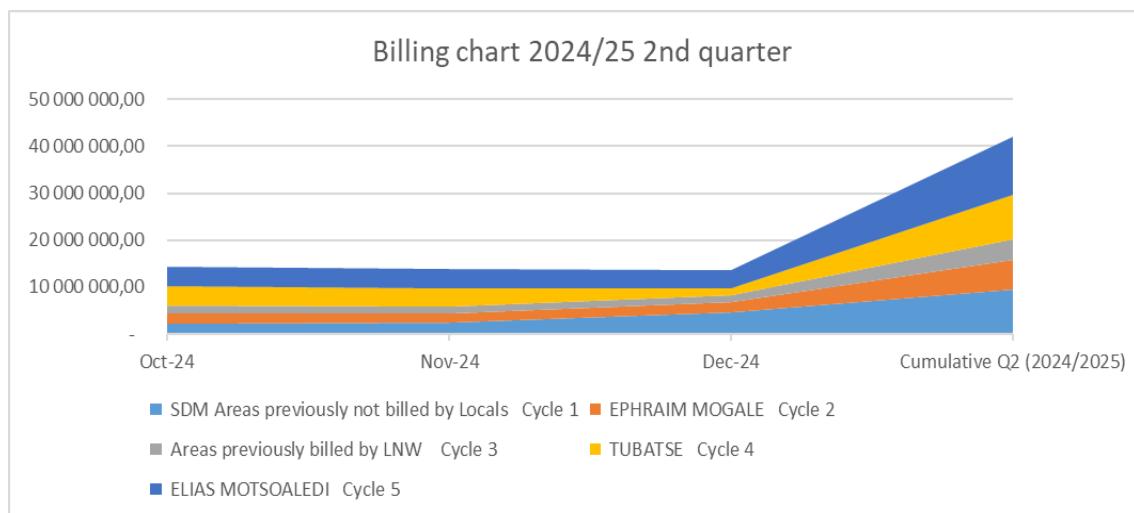

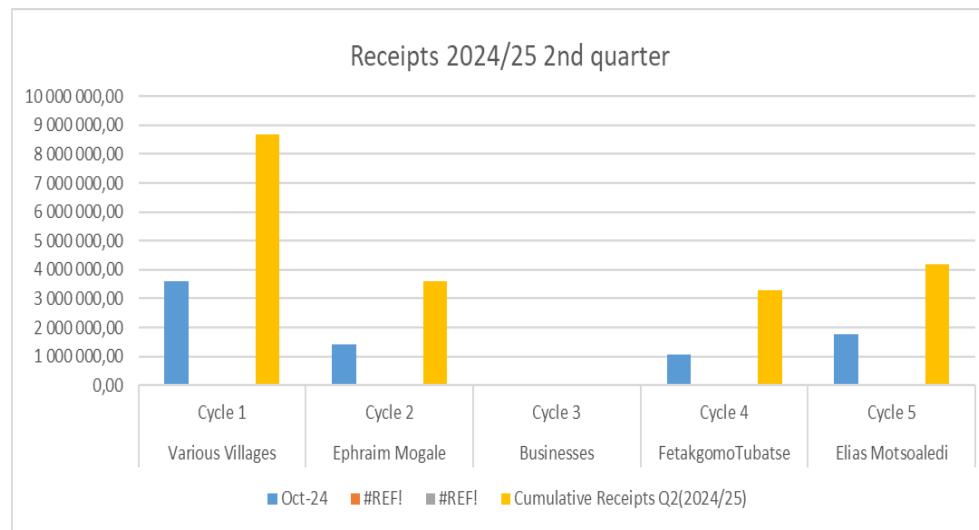
